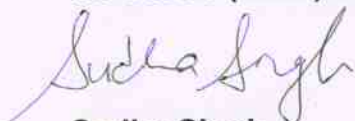

UK FOREIGN OFFICE CAT BEATS DOWNING STREET PET MOUSE-CATCHER
London: The rivalry between two world-famous cats in charge of prowling the political corridors of London to keep them mouse-free has a clear winner after new mouse-catching data was released on Monday. Palmerston, the UK Foreign Office cat, is being widely considered a winner over Larry, who is mostly only seen lazily strolling around at Downing Street.

ISRAEL TO GIVE \$1M AID TO HOUSTON JEWS
Jerusalem: Israel says it will donate \$1 million in emergency aid to Houston's Jewish community to aid in post-Harvey recovery efforts. Diaspora Affairs Minister Naftali Bennett says in a statement that the funds will be earmarked to help the 60,000 — strong community repair and rebuild schools, synagogues and a community center damaged in the storm and floods.

PALACE: WILLIAM, KATE EXPECTING 3RD CHILD
London: Britain's Prince William and wife Kate are expecting their third child, Kensington Palace announced on Monday, bringing delight to the royal family. There had been little indication that the 35-year-old Kate, the Duchess of Cambridge, was pregnant.

AU CHIEF: KENYA RULING 'DOES HONOUR TO AFRICA'
Conakry: The decision of Kenya's Supreme Court to annul the re-election of outgoing president Uhuru Kenyatta and order a rerun "does honour to Africa", African Union chief Alpha Conde said on Monday. The groundbreaking ruling on Friday annulling the August 8 presidential election was a first on the continent, where elections have often been tainted by intimidation and fraud.

TAIWAN'S UNPOPULAR PREMIER RESIGNS
Taipei: Taiwan's Premier Lin Chuan resigned on Monday in a move aimed at reviving dwindling public support for the government of President Tsai Ing-wen. Tsai's office announced in a statement that Lin tendered his resignation on Sunday, saying that he had "accomplished his periodic tasks", and it was approved by the President.

US warns N Korea

...of 'massive military response' to any threat

We have many options: Def Secretary Mattis

Asserting that it has "many options", the Trump administration has warned North Korea that "any threat to the United States or its territory, including Guam or our allies, will be met with a massive military response" that would be both "effective and overwhelming". The warning was held out by US Defence Secretary Jim Mattis after a national security meeting called by President Donald Trump on Sunday to deal with Pyongyang's latest nuclear "provocation", raising the stakes for several nations, including the United States.

Mattis said, "We have many military options. The president wanted to be briefed on each one of them."

"We made clear that we have the ability to defend ourselves and our allies, South Korea and Japan, from any attack. And our commitment among the allies is ironclad. Any

threat to the United States or its territories, including Guam, or our allies will be met with a massive military response, a response both effective and overwhelming," he said.

The Pentagon chief said that North Korean leader Kim Jong-un "should take heed of the United Nations Security Council's unified voice", noting that all members are unanimously agreed on the threat that Pyongyang poses. All are committed to de-nuclearisation of the Korean Peninsula "because we are not looking to the total annihilation of a country, namely North Korea", he added.

Meanwhile, the US at an UN Security Council meeting called for "strongest possible" measures against North Korea in the wake of a powerful nuclear test and warned that every nation that does business with Pyongyang and is aiding its "dangerous" nuclear intentions will be on its radar.

President Trump, meanwhile, had a telephone conversation with Japanese Prime Minister Shinzo Abe to discuss North Korea's "claimed test of a hydrogen bomb". "The two leaders condemned North Korea's

Japan at UN calls for new N Korea sanctions resolution

United Nations: Japan on Monday urged the UN Security Council to agree on a plan to draft a new sanctions resolution to punish North Korea after its sixth nuclear test.

"We cannot waste any more time," Japanese Ambassador Koro Bessho told reporters ahead of an emergency council meeting. "We need North Korea to feel the pressure — if they go down this road there will be consequences." AFP

N Korea could be preparing new missile launch: Seoul

Seoul: North Korea could be preparing another missile launch, Seoul said on Monday as it strengthened its defences following Pyongyang's biggest-ever nuclear test and declaration it had a hydrogen bomb.

The South and the United States will deploy more of the Terminal High Altitude Area Defence (THAAD) missile launchers that have infuriated Beijing, the Defence Ministry said. The announcement came after Seoul fired an early-morning volley of ballistic missiles in an exercise simulating an attack on the North's nuclear test site.

Pictures showed South Korean short-range Hyunmoo missiles roaring into the sky in the pale light of dawn from a launch site on the east coast.

Pyongyang said the device it detonated Sunday was a hydrogen bomb — far more

powerful than the fission-based devices it is believed to have previously tested — and small enough to fit into a missile. The blast threw down a new gauntlet to President Donald Trump, after the North in July twice tested an intercontinental ballistic missile (ICBM) that appeared to bring much of the US mainland into range, and threatened to send a salvo of missiles towards the US territory of Guam.

S Korean Defence Ministry estimated strength at 50 kilotonnes — five times size of North's previous nuclear test. They did not confirm whether it was hydrogen bomb, saying only "a variety of nuclear material" had been used. But Defence Minister Song Young-Moo said Seoul believed Pyongyang had succeeded in miniaturising its nuclear weapons to fit into an ICBM. AFP

2nd Indian student rescued from lake in Texas dies

A second Indian student has died here, days after she was rescued along with a compatriot from a swollen lake in the US state of Texas where Hurricane Harvey wreaked havoc.

Shalini Singh, 25, who was pursuing Masters degree in public health from the Texas A&M University, was rescued from the Lake Bryan, where she along with another Indian student Nikhil Bhatia, had gone swimming last Saturday.

While Bhatia died in hospital on August 30, Singh, who continued to be in a critical condition, was declared dead late last night by doctors.

Trump move could hurt 7,000 Indians

US Prez likely to scrap Obama plan with six-month pause: Report

An estimated 7,000 young Indian-Americans could be affected by President Donald Trump's reported decision to scrap an Obama-era programme that granted work permits to nearly 8,00,000 undocumented immigrants who arrived in the United States illegally as children.

Trump, set to make an announcement on Tuesday, has decided to phase out his predecessor Barack Obama's Deferred Action for Childhood Arrivals (DACA) programme with a six-month pause in

enforcement to give the US Congress an opportunity to come up with an alternative, Politico reported.

But there was no official word yet on Trump's reported decision, except that he would come up with an announcement on Tuesday. "A decision is not finalized. We will make an announcement on Tuesday," White House press secretary Sarah Huckabee Sanders said.

The DACA programme unveiled by former President Barack Obama in June 2012 by way of executive action sought to protect the 800,000-odd "dreamers" from deportation

and grant them work permits, allowing them to come out of the shadows and work legally.

While the overwhelming majority of "dreamers" — as much as 78 per cent — are from one country, namely Mexico, followed by some other Central American countries, India has been ranked 11th among countries of origin for DACA students in the US Citizenship and Immigration Services (USCIS) statistics as of March 31, 2017.

Under the programme, the Obama administration allowed young migrants, who came into the US illegally along with their parents, an opportunity to pursue their American dream, subject to meeting certain requirements.

must have entered the US before turning 16, have no serious criminal background and have lived continuously in the US since June 15, 2007. The programme cleared the way for "dreamers" to obtain driver's licenses, work permits and, in some states, concessional in-state tuition. Although Republicans were furious with Obama when he unilaterally announced what was perceived to be an amnesty-type programme for this category of illegal immigrants, party lawmakers are now divided on scrapping it.

"I actually do not think he (Trump) should do that. I believe that this is something that Congress has to fix," House Speaker Paul Ryan said in a radio interview on Sunday.

ROHINGYA CRISIS

Suu Kyi, Myanmar face chorus of anger

Nobel peace laureate Malala Yousafzai and Muslim countries in Asia led a growing chorus of criticism on Monday aimed at Myanmar and its civilian leader Aung San

Suu Kyi over the plight of its Rohingya Muslim minority.

Nearly 90,000 Rohingya have flooded into Bangladesh in the past 10 days following an uptick in fighting between militants and Myanmar's military in strife-torn western Rakhine state. The impoverished region bordering Bangladesh has been a crucible of communal tensions between Muslims and Buddhists for years, with the Rohingya forced to live under apartheid-like restrictions on movement and citizenship.

The recent violence, which kicked off last October when a small Rohingya militant group ambushed border posts, is the worst Rakhine has witnessed in years with the UN saying Myanmar's army may have committed ethnic cleansing in its response. De facto leader Suu Kyi, a former political prisoner of Myanmar's junta, has come under increasing fire over her perceived unwillingness to speak out against the treatment of the Rohingya or chastise the military.

She has made no public comment since the latest fighting broke out. "Every time I see the news, my heart breaks at the suffering of the Rohingya Muslims in Myanmar," Pakistani activist Yousafzai, who famously survived being shot in the head by the Taliban, said in a statement on Twitter. "Over the last several years I have repeatedly condemned this tragic and shameful treatment. I am still waiting for my fellow Nobel laureate Aung San Suu Kyi to do the same," she added.

Over 400 schools closed in Myanmar's Rakhine, 7 Hindus killed in attacks

Yangon: A total of 418 schools in three townships in Myanmar's northern Rakhine state have been closed as the Arakan Rohingya Salvation Army (ARSA) terrorists continued their attacks, in which at least seven Hindus were killed, media reports said on Monday.

Of the schools closed, 183 are from Maungta township, 212 from Buthidaung township and 23 in Yathedaung township, said Xinhua news agency citing local media. Over 80,000 students had enrolled in the Maungta district this academic year which started from June.

Extremist terrorists launched renewed attacks on 30 police outposts in northern Rakhine on August 25.

B'desh forces 2K Rohingya off remote island

Cox's Bazar: Bangladesh authorities have forced more than 2,000 Rohingya to leave a remote island where they were hiding out after fleeing violence in Myanmar, officials said on Monday.

The UN says 87,000 mostly Rohingya refugees have poured over the border into Bangladesh since the latest round of fighting broke out 10 days ago in Myanmar's neighbouring Rakhine state. The vast majority have entered overland or by crossing the Naf border river. But as desperation grows, some are braving the open seas to reach the small island of St Martin's nine kilometres off Bangladesh's coast.

Rohingya refugees with bullet wounds arrive in B'desh

Cox's Bazar: A hospital near Bangladesh's southeastern border has become overcrowded with dozens of Rohingya refugees who arrived with bullet wounds and broken bones after fleeing violence in western Myanmar.

By Monday, doctors were able to treat and release three men and a teenage boy, who with nowhere to go ended up squatting behind Cox's Bazar Sadar Hospital. They carried little with them aside from a few bed sheets and plastic bags holding personal documents. They had arrived at the hospital with 27 others, all of them "distressed and afraid" and telling stories about soldiers opening fire randomly on their villages in western Myanmar on Aug 26-27, according to the resident medical officer Dr Shaheen Abdur Rahman Choudhury.

The hospital, already "hugely overburdened," was expected to receive more wounded refugees in coming days. "What we are seeing is the tip of the iceberg," Choudhury said.
